While priority will be given to Veterans, they are not our only Heroes! Montgomery County First Responders (Police, Firefighters and EMS) will comprise our second tier of assistance. Any other available shelter will be afforded to homeless citizens of Montgomery County.



Hero Barracks - Emergency Shelter

We will provide Emergency Shelter (1-6 nights) at no cost, in one bedroom "Tiny Houses" and small two bedroom houses. In times of crisis, we will help individuals and their immediate family. Veterans will be given our top priority; First Responders (Police, Firefighters, and EMS Personnel) will comprise the second tier of support; and any remaining shelter/beds will be given to citizens of Montgomery County, TX. To be eligible for the top two tiers, factual evidence must be provided by the individual or parent (ex. DD-214, Retirement paperwork, VA ID Card, etc.) seeking shelter; as well as a Gov't ID, brief description of their issue, and if available, any supporting documents. Citizens of Montgomery County will have to show Driver's License; and if it is from out of state, a Utility Bill in their name. Our main HQ (Office) building will have computers, telephone lines and laundry facilities for use by our residents. Stays may be extended based on need and availability.
